# PROVEDA INDIA CORE PLUS SUCCESS PLAN

## DISTRIBUTOR ID ACTIVATION

To Activate your unique Proveda India ID in Repurchase Plan, Independent Distributor need to purchase product worth minimum 500 BV. The first purchase would not allow distributor to enter any of the income club of Proveda India. You would earn Retail Profit on your purchase in Proveda India.

## 1. RETAIL PROFIT

UPTO 50% (MRP - DP)

Retail Profit = Maximum Retail Price (MRP) - Distributor Price  
(The Price at which you buy products from company) (DP)

## 2. REPURCHASE CLUB

6%

### Consumer Club: (4% BV)

- To Qualify for consumer club Independent Distributor should do minimum repurchase of 500 BV in a month on his/ her Unique Proveda India ID
- 500 BV Repurchase on Proveda Unique ID in one month = 1 Consumer Club Point
- Consumer Club Point Value = 4% of BV Company Turn Over / Total Number of point collected in the same month
- Consumer Club Income: = Consumer Club Point Collected x Consumer Club Point Value

### Retailers Club: (2% BV)

- To Qualify for Retailer club Independent Distributor should do minimum repurchase of 3250 BV in a month on his/ her Unique Proveda India ID
- 3250 BV Repurchase on Proveda Unique ID in one month = 1 Retailer Club Point
- Retailer Club Point Value = 2% of BV Company Turn Over / Total number of retailer club point collected in the same month
- Retailer Club Income: = Retailer Club Point Collected x Retailer Club Point Value

## 3. STARTUP BONUS

24%

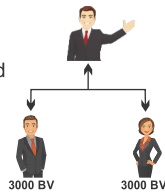
Start Up Bonus is a special bonus for young entrepreneur in Proveda India who achieve 1 point of Start-up bonus on matching of 3000 BV: 3000 BV and maximum of 200 points can be collected.

**1 Start Up Bonus = 3000 BV : 3000 BV**

Start Up Bonus Point Value = 24% of BV turnover of the company in a month/Total Number of Start Up Point collected in business month.

Start Up Bonus = Start Up Bonus Point Value x Start Up Bonus Point collected.

Eligibility Criteria : To Earn Start Up Bonus, Independent Distributor must have a repurchase of 100 BV on his ID.



## 4. TRAVEL FUND BONUS

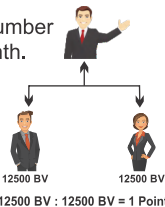
- To qualify travel fund independent distributor must complete 12500BV matching consecutive 2 months, if he/she get 12500BV or more matching after qualification than they are eligible for life time.

- 1 travel fund point = 12500BV:12500BV matching and it will increases in the same multiple.

- Point Value = 10%Bv turnover of the company / total number of travel fund points generated in the company in a month.

- Travel Fund Bonus = Total number of points achieved x Travel Fund point value

- Maximum threshold limit of earning travel fund is 350 points and To earn Travel Fund Bonus, Independent distributors must have a repurchase of 250 BV



## 5. CAR FUND BONUS

10%

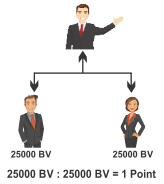
- To qualify for car fund independent distributor must complete 25000BV matching consecutive 3 months, if he/she get 25000BV or more matching after qualification than they are eligible for life time.

- 1 Car Fund Point = 25000BV : 25000 BV matching and it will increases in the same multiple.

- Car Fund Point Value = 10%Bv turnover of the company in a month / Total number of car fund points generated in a month.

- Car Fund = Total number of points achieved x Car Fund Point Value.

- Maximum threshold limit of earning car fund is 200 points and To earn car Fund, Independent distributors must have a repurchase of 500BV.



## 6. STAR BONUS

12%

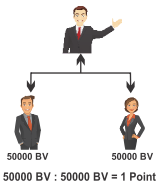
- To qualify Star Bonus independent distributor must complete 50000 BV matching.
- 1 Star Bonus = 50000BV:50000 BV matching & it will increases in the same multiple.

- 1 Point Value = 12% BV turnover of the company / total number of Star Bonus Points generated in the company in a month.

- Star Bonus = Total number of points achieved x Star Bonus point value.

- To earn Star Bonus, independent distributors must have a repurchase of 500 BV.

- Maximum threshold limit of Star Bonus points is 250 points.



## 7. LIFE STYLE BONUS

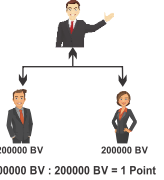

- To qualify for Proveda Lifestyle Bonus one should have 2 lakh BV : 2 lakh BV in both the organization to get 1 point and points will increase in the same multiple.

- 1 Point Value = 8% BV turnover of the company / total number of Proveda Lifestyle Bonus Points generated in the company in a month.

- Proveda Lifestyle Bonus = Total number of points achieved x Lifestyle bonus point value.

- To earn Proveda Lifestyle Bonus, independent distributors must have a repurchase of 2000 BV.

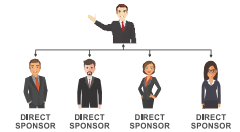


## 8. MENTORSHIP BONUS

Earn 8% of the income of your direct sponsor which they earned from startup bonus, travel fund, car fund and star bonus only.

**Note :** To Earn Mentorship Bonus Distributor must have self repurchase of 250 BV in the same month.



## 9. LIFETIME ROYALTY BONUS

1%

- Distributors achieve the Lifetime Royalty Bonus when he / she is able to match business of 25,00,000 BV in his/her main organization and other organization.
- To give away the Lifetime Royalty Bonus Proveda allocates fund of 1% of its monthly BV turnover and equally divides the allocated amount among all the Lifetime Royalty Bonus achievers.
- To earn Lifetime Royalty Bonus, Independent Distributors must have a monthly repurchase of 2000 BV.
- To earn Lifetime Royalty Bonus, minimum 1 Star Bonus is required in other organization. Lifetime Royalty Bonus is paid to the family of Independent Distributors after their death without any conditions applicable.

## 10. ANNUAL ROYALTY BONUS

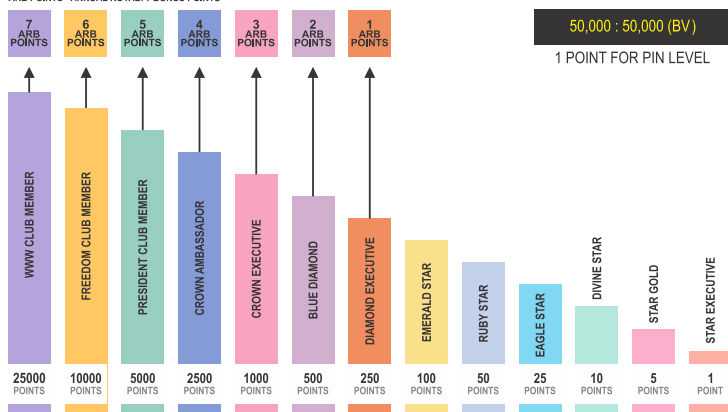
**Annual Royalty Bonus is calculated as per below mentioned formula:**

Annual Royalty Bonus Point (ARBP) Value = 1.5% BV Company's Turnover / Total No. of Points.  
Annual Royalty Bonus = Annual Royalty Bonus Points (ARBP) x ARBP Value.

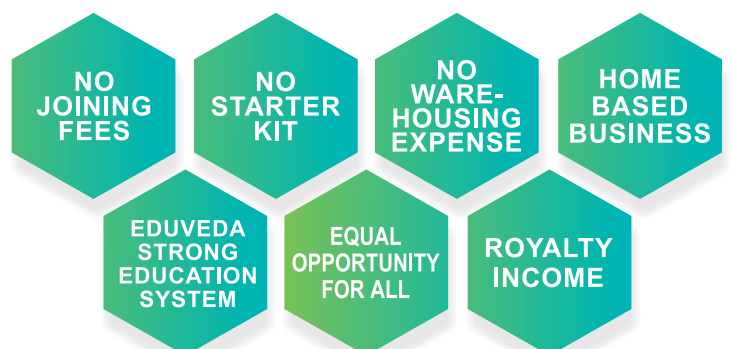
**NOTE:** 1 point of Annual Royalty Bonus Point (ARBP) can be achieved by achieving diamond executive rank. Next ARBP will be added with the new rank achievement.
